EXHIBIT B  
CRYSTAL SPRINGS GOLF COURSE  
RULES AND REGULATIONS

In order to enhance the golf experience and safety of all persons and guests at the Crystal Springs Golf Course (the "Golf Club"), the following rules and regulations ("Club Rules") shall govern the actions and conduct of all members and their guests at the Golf Club.

Use of Facilities

Member is entitled to use and enjoyment of the Golf Club, subject to the terms and restrictions of the applicable membership plan, these Club Rules, and such other restrictions or limitations as may be imposed from time-to-time by management. All modifications to rules will be appropriately distributed to members in writing.

Members must check-in with the Golf Shop on every visit and sign for a golf cart at all times. Failure to check-in with the golf shop may result in a suspension or termination of membership.

All play starts on Hole #1 unless directed otherwise by the golf shop staff. Skipping holes and playing multiple balls is not permitted. Members are expected to follow all course rules, pace of play expectations, fix ball marks and repair divots.

Club equipment such as golf carts, range mats, range baskets, maintenance equipment etc. are Crystal Springs property and not to be removed from the facility.

The Golf Club reserves the right to host special events and golf tournaments. Such events may partially or completely restrict the availability of golf course starting times and any or all Golf Club facilities, including, but not limited to use of the clubhouse, snack bar, practice range, and the golf course itself. The Golf Club shall have no liability for the temporary suspension of any privilege due to maintenance, repair, construction, improvements, acts of God, inclement weather, utility disruptions, or any and all other matters beyond the control of the Golf Club.

The management of the Golf Club shall be free to modify the features of the facilities, including but not limited to the relocation of operations, the implementation or cessation of services, the privatization of 18 holes, or such other adjustments or changes as management, in its discretion, deems appropriate.

### Reservation Policies

The Member shall make prior reservations for tee times according to the applicable Member's plan. Starting times that are not cancelled or modified to more or less players at least 2 hours in advance of play will be addressed as follows:

- 1<sup>st</sup> Offense: Member warned and notation placed in file
- 2<sup>nd</sup> Offense: Member's Account will be charged \$25 per no-show time
- 3<sup>rd</sup> Offense: Member will lose ability to book tee times in advance for 30 days

All players must check in at the golf shop at least fifteen (15) minutes prior to a reserved starting time. Failure to do so may result in a cancellation or delay of the tee time if other parties are prepared to play or on standby.

### Guest Policies

All guest fees are payable at the time of play. No discounted rates for guest play is offered at this time. Annual paying members receive 4 comp round vouchers per year.

### Pace of Play

Players are required to keep pace with the group in front of them at all times and/or to complete 18 holes in four hours and thirty minutes, whichever is less.

### Use of Golf Carts

Golf carts are to be driven in accordance with applicable cart restrictions at all times, and otherwise in a safe and controlled manner. Golf carts are allowed on the fairways of all par 4's and 5's at a 90° angle from the ball to the cart path. Par 3's at Crystal Springs are cart path only at all times. However, inclement weather or other conditions may evoke further cart restrictions. The staff will notify players of any temporary restrictions, but players are expected to refrain from driving golf carts where it may damage the golf course. Privately owned golf carts are not allowed. No more than two (2) carts per foursome are allowed. No more than two (2) riders and two (2) golf bags per cart.

### Transfers and Revocations

Membership privileges are personal to the Member and may not be sold, transferred, or otherwise assigned in any manner. The management of the Golf Club may revoke any membership without notice if a member violates any terms of the membership plan, general policies of the Golf Club and/or these Club Rules, as the same may be hereafter modified. No portion of any fees paid is refundable upon revocation. Club Rules may change from time to time at the discretion of management. All memberships expire as of the end of their stated term. Members on a monthly membership plan will become month-to-month members after completion of the initial term.

### Membership Changes and Cancellation

Changes and/or Cancellations to Membership Status are accepted after the initial term of each membership. A written Change Form must be submitted to the Golf Club and signed by an authorized Golf Club representative. Members are responsible for submitting changes a minimum of five (5) business days prior to the desired effective change date. Membership Classification changes will not be accepted via telephone or fax. Official Change of Status forms can be obtained through the Golf Club's Golf Shop and Administrative Offices. No portion of any fees paid is refundable upon cancellation

of Membership. Member is responsible for paying the minimum monthly dollars for the entire duration of the initial term of membership.

#### Payment of Fees and Charges

Membership fees are due and payable at the time the membership term begins as specified in the Membership Application and are non-refundable. Monthly fees and additional charges may be automatically charged to Members credit card on file monthly, provided a Credit Card Authorization Form has been completed.

Membership fees will be charged on a monthly basis to the credit card on file for the duration of the membership or a minimum of 12 months from the membership start date. Monthly membership will continue on a month-to-month basis following the 12 month commitment with the option to cancel with 30 day written notice. Early cancellation or termination of membership may be done with an early fee termination fee equal to one-half of the remaining membership fees to meet the 12-month minimum commitment.

Charging Privileges are allowed only to the Member's Account with a completed application, including valid credit card information to be kept on file. The Member's credit card will be charged at the beginning of each month for the full balance on the account. The Member is responsible to provide the Golf Club with any changes to the credit card account. Failure to pay account in full by the 15<sup>th</sup> of each month may result in suspension of charging privileges or suspension/termination of membership.

#### Indemnification for Damage

Member shall be responsible for all damages and personal injury caused by the Member, the Member's family, or any guest of the Member, and the Member shall indemnify, defend, and hold harmless the Golf Club against any claims.

#### General Limitations

The Golf Club shall have no liability for the physical damage, theft, or loss to any personal property of Member or Member's guests in any way arising from the use of the Golf Club facilities, to the greatest extent allowed by law.

#### Affiliated Clubs

Membership in Crystal Springs Men's and/or Women's Clubs is including in the one-time initiation fee. This includes NCGA Membership, GHIN Number and access to Men's and Women's Club events and outings. In subsequent years, annual renewal fees are payable to the appropriate Affiliated Club directly. The Golf Club shall have no liability for the decisions, rules, regulations, acceptance and financial matters of the Crystal Springs Men's Club or Crystal Springs Women's Club. Members must adhere to the Men's & Women's Club by-laws at all times.

#### Medical Leave

Medical leave is only offered once every three years and is only extended for a three month period. You must provide a written doctor's note with your request. Any request may be denied or approved by the General Manager.
