## TWILIGHT (PDP) MEMBERSHIP RULES

- Golf benefits begin at the public start time for twilight rates and is for the **MEMBER'S USE ONLY**. Twilight and Late Twilight times will vary throughout the year based on available daylight.
- Range benefits are available any time but limited to 2 buckets of range balls per day.
- PDP membership may not be used for tournaments, leagues or special events.
- Golf cart is optional and not required, additional fee per person to ride in a power cart. All golf cart rules apply include being over the age of 18 to rent a cart, limit two people per cart, abiding by cart rules and subject to availability. Single golfers are expected to share a cart with other singles and threesomes, unless State or County mandates single rider carts. **Not sharing a cart will result in an additional \$12 per round.**
- Golfers **MUST** check into the pro shop prior to playing. Play starts on Hole #1 unless directed otherwise by golf shop staff. Skipping holes and playing multiple balls is not permitted.
- PDP members are expected to follow all course rules, pace of play expectations, fix ball marks and repair divots.
- Range cards will be issued to all members upon signing of this contract. Replacement range cards (lost or stolen) can be purchased in the golf shop for \$5. The original card will be de-activated at that time.
- **Range balls are for the member's use only. Membership privileges cannot be shared and are not transferrable. Range balls, baskets and other CSGC property must not be removed from under any circumstances. Unused range balls should be returned to the pro shop and not left on the driving range.**
- **Lessons and instruction by unauthorized personnel is strictly prohibited.**
- Violation of PDP program or Crystal Springs GC rules can result in suspension and/or termination of membership without refunds of any fees.

Membership fees and privileges are valid from date of purchase for 12 months and are not refundable nor transferable. Membership cards issued at the time of purchase must be presented to the golf shop staff when utilizing all membership benefits and may be verified by staff. No personal information given in this application will be sold to third parties.

Membership fees will be charged on a monthly basis to the credit card on file for the duration of the membership or a minimum of 12 months from the membership start date. Membership will continue on a month-to-month basis following the 12 month commitment with the option to cancel with 30 day written notice. Early cancellation or termination of membership may be done with an early fee termination fee equal to one-half of the remaining membership fees to meet the 12-month minimum commitment. Membership privileges will be suspended if payment is not able to be processed at the beginning of each month.

By signing below, I acknowledge that I have read and understand the program guidelines and agree to abide by these rules, which along with this application contain the complete agreement between the parties. I understand that Crystal Springs Golf Course reserves the right to revise, modify, or withdraw the PDP Membership or any feature of the program at any time without prior notice. Crystal Springs Golf Course reserves the right to refuse or revoke a membership at its discretion.

I hereby waive and release all rights and claims for damages I may have against Crystal Springs Golf Course, its respective agents, owners, representatives, and successors for any and all injuries suffered by me in connection with my participation in the PDP program and usage of the Crystal Springs facilities during my current membership period. I agree that I am liable for any damage caused by my errant golf shots or negligence to property, including golf carts, or persons.
